

## 24.12 – Workshop Game Rules

## Game Entry

Participants may enter by:

2. Optionally increasing their chances by replying to the confirmation email with a receipt for dining at the restaurant in December 2024. This receipt must be sent as a reply to the automatic confirmation email.

This additional receipt submission is optional and not required for participation.

## Draw and Winners

- The Organizer will draw the winner(s) from all valid entries received before the deadline.
- If a selected winner fails to respond in writing within 2 days or declines the prize, another winner will be selected.
- Winners will be notified by email within 5 business days of the draw.

## Participation Conditions

To participate, the entrant must:

- Submit one valid entry via the official link before the deadline.
- Provide a valid email address and confirm participation via newsletter registration.
- (Optionally) Submit a December 2024 restaurant receipt to increase winning chances.

- Accept the Game Rules and Data Protection Terms.
- Have an active Facebook or Instagram account at the end of the game.

Each person may only enter once with one email address.

## Prize

The prize consists of **10 spots** for a Private Pizza-Making Workshop held at Donna Mamma Pizza Napoletana restaurant.

- Each winner will receive **1 invite** (1 spot per person).
- The event date will be pre-determined and communicated via the contact information provided by the winners.
- The prize is not redeemable for cash and is non-transferable.
